Resin Infiltration. Beyond the White Spot. Insights from a Paediatric Dentist.

SYNOPSIS

Resin Infiltration is a minimally invasive technique to manage the white spot lesion. Demineralized enamel is infiltrated with resin, thus improving the visual appearance. Perception that this is just aesthetic dentistry, ignores the underlying cause of the white spot lesion. The operator is thus skimming the surface in the management of this patient. Not all white spot lesions are amenable to this technique. This lecture discusses the anatomy of the white spot lesion, case selection, and pitfalls to avoid. Resin infiltration seems a simple technique. Dr Tan gives insight on why “The simplest things are the most difficult - Carl Jung”
